Compliant to the requirements set out in Art. 3 of Commission Regulation (EU) No. 1935/2004 of 27. October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, the material(s) used in these products are chosen for their technical quality as well as purity suitable for contact with foodstuffs. Current amended version with 2019/1381 (20 June 2019) is included.

The products listed above are manufactured pursuant to the requirements outlined in European legislation regarding labelling and traceability.

EU Commission: In accordance with EU Commission Regulation no. 1935/2004 this product is intended for food contact. Therefore it can be marked with the "glass & fork" symbol either on the packaging or through labelling.

Products are manufactured according to EU Commission Regulation no. 2023/2006 on good manufacturing practices for materials and articles intended to come into contact with food (GMP).

Specific sensory and migration test are made on similar products. Under Directive (EU) No. 84/00 the above articles belong to Category 1 & 2 as defined in Art. 2, (4) of (EU) No. 84/500.

Specific migration of lead and cadmium: In accordance with Directive (EU) NO. 84/500, relating to ceramic articles intended to come into contact with foodstuffs the above articles were found not to release any detectable amount of lead or cadmium, when subjected to a test with 4% acetic acid at 22°C, for 24h (ISO 6486).

Specific migration of aluminium, arsenic and cobalt: using the methods described in ISO 7086-1 and 2 the above glass articles were found not to release any detectable aluminium, arsenic or cobalt, wwhen subjected to a test with 4% acetic acid at 22°C, for 24h.

Max. temp (foodsafte): 80 °C

Max. temp (warming): Not suitable for warming.

Suitable for: All drinks and foodstuffs.

Max. Wash temp: Dishwasher-safe.
